

## **Top 3 Things to Know**

**Educator Raises -** The House Ways and Means Committee... Our collective voice is being heard! In their budget announcement, the House Ways and Means Committee included a \$4000 increase to every step of the teacher salary schedule, a 5% bus driver pay increase, and an increase in classroom supply money to \$300.

The SCEA has been advocating for South Carolina to increase starting teacher salary to the national average of \$41,163, as well as equivalent increases for every step of the schedule and for support staff.

President Sherry East recently spoke with Nick Reagan of Charleston News 5 about The SCEA's advocacy and the need for continued advocacy on this issue. This positive step towards the national average shows the collective power of educators speaking out as one voice. We must keep raising our voice as one to achieve the conditions all South Carolina educators, school staff, and students deserve. **Click here to take action!**

2 Honesty in Education - This Tuesday the House Education and Public Works Committee will be meeting a second time to listen to public testimony on several bills that seek to that pit parents against educators. <u>H.4325</u>, <u>H.4343</u>, <u>H.4392</u>, <u>H.4605</u>, and <u>H.4799</u> Read The SCEA's submitted testimony from the previous hearing here. On their surface, these bills claim to focus on banning "Critical Race Theory" but in actuality impose top-down censorship policies about topics not part of the SC education standards. **Read more to learn how to take action!** 

**3** Senate Voucher Fight - The Full Senate Education Committee met for a the first time to discuss voucher bill <u>S.935</u> as a full committee on Wednesday. In the past seven meetings, many concerns were expressed by educators, parents, and constituents, as well as by Subcommittee Members Senator <u>Jackson</u> (Richland) and Senator <u>Hutto</u> (Orangeburg). In fact, over 700 South Carolina constituents have used The SCEA's call to action to ask the Subcommittee to urge them to oppose <u>S.935</u>.

No action was taken during Wednesday's meeting. However, the Committee discussed the bill and several amendments, and has adopted the subcommittee amendments on S. 935 as a working document, which can be read here.
