Legislative Update Week 10

March 19, 2022

Top 3 Things to Know

House Budget - The House began debate on the state's \$14 billion budget on Monday, and approved it later that evening. Traditionally the budget debate continues for days, but this year was different with the House's quick passage. There was little debate, with most of the discussion on amendments centered on the state's health plan and abortion services, potential vaccine passports, state employee pay bonuses, and a pay raise for legislators.

The proposal for a \$4,000 increase to the **state minimum** salary schedule <u>did not change</u>. It's important to note that many educators would not receive a raise based on the proposal. <u>You can advocate for your legislators to fund raises for *all* educators and school staff by clicking here.</u>

Few amendments were successful, but a PEBA exemption from earning limitations was approved, as was a suspension of name image likeness endorsements for collegiate athletes.

The budget has been sent to the Senate Finance Committee for consideration.

2 **Open Enrollment** - The Senate Education Subcommittee met once again to discuss **5.544**, a statewide open enrollment bill. The SCEA has several concerns about this legislation that have yet to be addressed. <u>The SCEA testimony from March 2nd outlining our concerns can be read here</u>.

During this meeting, <u>3 amendments</u> were proposed by Senator Talley (Spartanburg). Of the amendments, 2 passed and 1 was carried over. The first amendment that passed

(Amendment No. 1) clarified language that open enrollment language to be inter-district rather than intra-district. The second amendment that passed (Amendment No. 3) amended the process for applying for open enrollment and the process for appealing denials.

The amendment that was carried over (Amendment No. 2) attempted to set the application deadline of the process to Jan. 31st and to allow a district to charge a fee for out-of-district students to help school districts cover differences in the cost of funding an open enrollment student. The full meeting summary can be read here.

S.544 will be discussed by the Full Senate Education Committee this Wednesday.

3 *S.531* - On Tuesday, the Senate Education Subcommittee heard testimony on and chose to give a favorable report to <u>S.531</u>, legislation that seeks to prevent transgender from participating in sports. **S.531** is similar to many bills around the country that attack transgender youth. NEA General Counsel published a memo breaking down legislation from around the country with steps educators can take. <u>NEA EdJustice also has a page</u> dedicated to supporting LGBTQ+ youth where you can become informed and take action.

State Superintendent's Race

This week former educator Representative Jerry Govan Jr. (Orangeburg) announced his bid for South Carolina state superintendent of education during a press conference at the Statehouse on Friday. Representative Govan will run as a Democrat.

In the press conference, among other issues, Representative Govan announced increased pay for educators as a high priority. The floor for first-year teachers in the House's budget proposal approved March 14 is \$40,000, but Govan wants to raise it to \$60,000.

Only three candidates have officially filed to run: Ellen Weaver, Kizzi Gibson, and Sheri Few —all as Republicans. Several other candidates have also declared their intention to run for Superintendent Molly Spearman's soon-to-be vacant seat.
