

Legislative Update Week 12 April 3, 2022

Top 3 Things to Know

Vouchers pass the Senate - On Wednesday the Senate voted <u>25-15</u> to pass a harmful voucher bill, <u>S.935</u>, which creates a private voucher system.

Debate lasted many hours Tuesday and Wednesday, with several Senators fighting to amend the bill and raising points about how the bill allows for discrimination, violates the South Carolina and US Constitution, and how it does nothing to improve the education or lives of the majority of South Carolina's students or to address the historic teacher and school staff shortage crisis in our state.

2 Anti-Truth Legislation - On Tuesday, the House Education & Public Works discussed language on a committee bill now known as <u>H.5183</u>.

H.5183 was written following several hearings on anti-Truth bills **H. 4325, 4343, 4392, 4605**, and **4799**. However, the public and educators were given no opportunity to review and be heard on the new bill prior to the committee voting to adopt the language.

Twelve legislators—Representatives Allison, Lin Bennett, Brittain, Calhoon, Felder, Gatch, McGinnis, Moore, Morgan, Oremus, Smith, and Trantham voted yes. Five legislators— Representatives McDaniel, Govan, Alexander, Henderson-Myers, and Rivers—voted no. <u>The full meeting summary can be found here</u>.

Despite objection on point of order from Representatives Govan and McDaniel, **H.5183** was introduced, read for the first time, and placed on calendar without reference on Wednesday.

H.4608 - The House K-12 Subcommittee met on Wednesday to discuss <u>H,4608</u>, a bill that seeks to prevent transgender youth from participating in sports. **H. 4608** is similar to many bills around the country that attack transgender youth.

Despite testimony from experts, many impacted in the community and even from Representative John King, the subcommittee voted 4-2 to give the bill a favorable report. Only Representatives Alexander and Rivers voted no. <u>A full subcommittee meeting summary can be heard here</u>.

On Thursday, the full House Education and Public Works committee <u>met for less than 10</u> <u>minutes</u> before voting to give the bill a favorable report. The vote also coincided with the celebration of the International Transgender Day of Visibility, which was formally recognized by President Joe Biden in a proclamation last year. <u>A full meeting summary of this very brief</u> <u>meeting can be found here</u>.

Members of the House Rules Committee, voted to fast-track the bill, which will be taken to the floor on Tuesday, where it needs a two-thirds vote to get on the calendar.

<u>According to an article from the Post & Courier</u>, members of the Rules Committee acknowledged the legislation is not the most pressing issue facing South Carolinians and that there have been no issues allowing transgender student athletes to compete in women's sports.

NEA General Counsel <u>published a memo</u> breaking down legislation from around the country with steps educators can take. <u>NEA EdJustice also has a page</u> dedicated to supporting LGBTQ+ youth where you can become informed and take action. SC United has put together a <u>toolkit</u> on **H.4608** and similar legislation to help you get information and take action, too.

Use Your Educator Voice!

Senators who did not vote for the harmful voucher bill S.935. <u>Fifteen Senators</u> listened to educators and voted against S.935.

They are Senators Fanning, Jackson, Hutto, McLeod, Kimpson, Allen, Kevin Johnson, Malloy, Martin, Matthews, McElveen, Sabb, Scott, Stephens, and Williams.
