Censorship

The Senate Education Subcommittee heard public testimony on <u>H.3728: "South Carolina Transparency and Integrity in Education Act"</u> on March 14, but the committee ran out of time for everyone who signed up to testify. The next scheduled public hearing is Wednesday at 9:30 a.m.

The SCEA strongly opposes this bill.

Every single South Carolina child deserves to receive an honest, accurate education that prepares them for the future—no matter their zip code. This bill inserts the state government into classrooms, jeopardizes educators' ability to provide an accurate education, and could prevent students from learning about vital parts of our state's history. Students need to learn the good and the bad of our shared history so that they can learn from the mistakes of the past to create a better future.

Gender Identity

The Senate Medical Affairs committee heard testimony from invited parties on <u>S.627</u> on Thursday.

The majority of this this bill, which was introduced last week, pertains to medical care, except for a section that prevents employees of public schools from "knowingly withholding from a minor's parent or legal guardian information that [their] gender is inconsistent with [their] sex."

It also requires educators to inform parents/legal guardians if they "know or suspect that a student suffers from gender dysphoria [or] gender identity disorder."

The SCEA fears this bill could strip educators of their privacy and prevent a safe environment for them to effectively communicate with students. It could also make teachers the arbiters of appropriate gender behavior and expression and could force educators to out transgender and nonbinary students. All South Carolina educators and students deserve to feel reflected, respected, and protected in public schools.

Statewide Education and Workforce Development Act

On Thursday, the Senate Education Committee heard both H.3726: Statewide Education and Workforce Development Act and S.305. The committee reported favorably on both bills.

S.305 states that an "individual's prior work experience may be awarded on an initial teaching certificate if the prior experience is in or related to the content field of the certificate" and that "existing certificate holders may also receive the same credit for prior work experience."

H. 3726: Statewide Education and Workforce Development Act aims to consolidate workforce development entities and streamline the development process by creating the Office of Statewide Workforce Development Coordination within SCDEW, which would oversee publicly funded workforce development services.

Bills That Saw No Movement, but We Continue to Monitor

<u>S.285</u>, Providing Academic Choice in Education, encourages companies, institutions, or individuals to fund scholarships for students to attend private schools. Donors would receive a state tax credit up to \$10,000. The current program only applies to special-education students. Supporters of the bill believe it would provide parents with more options to send their child to private school. The bill passed the Senate but is still waiting for a House subcommittee hearing.

<u>H.3591</u> would repeal an amendment in the state constitution that prohibits the use of public tax dollars to fund private and religious schools. H.3591 would allow legislators to provide public funds into private schools that can discriminate against certain children. This would also remove funding from public schools, further harming the remaining students. This bill saw no movement this week and remains in the Senate Committee on Judiciary.

Teacher Contracts: As The SCEA discussed during its <u>Facebook Livestream</u>, and pursuant to S.C. Code Ann. § 59-25-420, teachers who have been offered reemployment by the district must notify the district's board of trustees in writing of their acceptance of the contract before May 11 (i.e., by May 10). If you are thinking about switching jobs or are making a career change, don't sign until the deadline.

Introductions of Interest

S. 654: Barnwell School District Consolidation Hutto

 Senator Brad Hutto (D-Orangeburg) has introduced legislation to consolidate the Barnwell County School Districts into a single district. It was deemed a local bill and was given 2nd Reading on Thursday.

<u>S. 671:</u> Language Equality and Acquisition of Deaf Kids Act (LEAD-K) Talley

Senator Scott Talley (R-Spartanburg) introduced a bill to enact the
"Language Equality and Acquisition for Deaf Kids Act" to develop a resource
that parents of deaf or hard-of-hearing children may use to monitor and
track expressive and receptive language and the developmental states
towards English literacy. The bill was referred to the Senate Education
Committee.
