

#### Legislative Update Week 8

# The Ballot Initiative

The House approved legislation this week by a vote of 83-27 to place a referendum on the 2024 ballot to allow direct funding of private schools with state dollars.

The legislation (H.3591) would repeal the state constitution's ban on private schools receiving public funds. Opponents argue that public funds would be better allocated to the public education system.

The bill now moves to the Senate where it needs 31 Senators to vote in favor. To see the potential ballot question: click here.

### **School Safety and Targeted Violence**

The House Education and Public Works Full Committee heard several bills this week.

<u>H.3360: Center for School Safety and Targeted Violence</u> establishes a center within the South Carolina Law Enforcement Division (SLED) to produce extensive training, education, and expertise in school safety and targeted violence.

The bill comes as the number of threats directed at schools has significantly increased. The SCEA testified in favor of the bill because we support any legislation that protects educators, staff, and students from harm.

The bill was reported favorably out of committee and now moves to the House floor.

## **School Psychologists Certification**

The House Committee also heard <u>H.3308</u>: <u>School Psychologists</u>, a bill that will give temporary certifications to school psychologists, social workers, and guidance counselors that are certified in another state until they can become certified in South Carolina.

The bill also received a favorable report and will now move to the House floor.

## **Open Enrollment**

The House Education and Public Works Committee reported favorably on <u>H. 3843: Open</u> Enrollment.

This bill would diminish district lines and allow students to attend schools outside of their district if the school has space.

### **Sunscreen in Schools**

Specialists, parents, and students have all emphasized to legislators the importance of allowing sunscreen in schools, since skin cancer is the most common cancer in the United States. <u>S.256</u> will allow students to have and apply sunscreen in public schools, which previously required permission from a doctor or parent to have.

The bill was read a third time by the Senate and is currently in the House Education and Public Works Committee.

## **Aspiring Educator Scholarships**

<u>S. 125: Scholarship Stipend</u> would encourage students to pursue a career in education by providing scholarships for aspiring teachers to lessen their student debt burden while receiving their degree.

The bill was passed by the Senate 38-0 and now heads to the House, where it is expected to be debated in the upcoming weeks.

## **Fire Drills**

<u>S.203: Public School Drills</u> was passed by the Senate and is currently in the House Education and Public Works Committee. This bill would remove conflicting language to unify each school district's fire drill policy. This will lessen classroom disruptions due to drills while still ensuring students are prepared for emergency situations.

### **Statewide Education and Workforce Development Act**

The Labor, Commerce, and Workforce Development Committee heard <u>H. 3726: Statewide</u> Education and Workforce Development Act.

This bill aims to consolidate workforce development entities and streamline the development process by creating the Office of Statewide Workforce Development Coordination within SCDEW, which would oversee publicly funded workforce development services. The committee gave <u>H. 3726</u> a favorable report.

The House also introduced <u>H. 4060</u>, which directly addresses the education aspect of H. 3726. It is currently in the House Education and Public Works Committee.

### Vouchers

<u>"Academic Choice in Education" (ACE) (S.285)</u> is a voucher scheme that will use tax credits to indirectly fund private and religious institutions that could discriminate against students.

This bill did not see any movement in the legislature this week. The other voucher scheme bill, <u>"Scholarship Trust Fund Bill" (S.39)</u>, remains in committee.

The SCEA will continue to provide updates as these bills move through the legislature.

### Censorship

The Senate scheduled a subcommittee hearing to discuss <u>H. 3728: "South Carolina</u> <u>Transparency and Integrity in Education Act,</u>" on March 14th.

This is a censorship bill that could limit discussions of race, gender, and other important issues in K-12 and higher education classrooms, making it difficult for many teachers to accurately teach their subjects and restricting educators' ability to respect, reflect, and protect all students in their classrooms.

Additionally, this bill requires schools to share curricula with parents and create a complaint form that parents, other students, and school employees can use to challenge lessons or curriculum components they believe violates this law.

The SCEA fears that many educators may become burdened with unnecessary complaints and fears for the future of accurate education in Black history and other cultural topics.

### **Introductions of Interest**

Below are bills that were introduced in the House and Senate this week that may be of interest to you. We have provided a brief description as well as a link to the full text of each bill. Please review and let us know if you have any comments or concerns.

#### H. 4043: North Charleston School District

Pendarvis

Representative Marvin Pendarvis (D-Charleston) introduced a bill that establishes North Charleston School District as an independent and autonomous school district, separate from the Charleston County School District. The governing body of the North Charleston School District would consist of a board of trustees which shall be composed of seven members. The bill was referred to the Charleston Delegation as local legislation.

#### H. 4045: Accrediting Commission of Career Schools and Colleges

#### Murphy

Representative Chris Murphy (R-Dorchester), Representative Gary Brewer (R-Charleston), Representative Robby Robbins (R-Dorchester) and others introduced a bill to recognize the Accrediting Commission of Career Schools and Colleges for purposes of the Palmetto Fellows, LIFE and SC Hope Scholarships. The bill was referred to the House Ways and Means Committee.

#### S. 579: STEM Education Day 2023

#### Loftis

Senator Dwight Loftis (R-Greenville) introduced a resolution to declare April 12, 2023 as "STEM Education Day" in South Carolina. The resolution was adopted and referred to the Senate Education Committee.

#### H. 4060: Education and Workforce Readiness

#### Smith

Representative Murrell Smith (R-Sumter), Representative Jay West (R-Anderson), Representative Nathan Ballentine (R-Richland) and others introduced a bill to establish a "Statewide Workforce Readiness Goal" to ensure that all public high schools, including charter high schools, provide academic remediation courses in high school literacy and mathematics for students in the senior year of high school who desire to pursue a postsecondary education but are not academically prepared for college-level course work. The bill was referred to the House Education and Public Works Committee.

#### S. 582: Theater in our Schools Month

Massey

Senator Shane Massey (R-Edgefield) introduced a resolution to recognize March, 2023 as "Theater in Our Schools Month." The Senate resolution was adopted.

#### H. 4069: Technical College Students on 2023 All-State Academic Team

#### Erickson

Representative Shannon Erickson (R-Beaufort), Representative Terry Alexander (D-Florence), Representative Carl Anderson (D-Georgetown) and others introduced a resolution to recognize and congratulate the forty-three South Carolina technical college students named to South Carolina's 2023 All-State Academic Team by the Phi Theta Kappa Honor Society in recognition of their scholarly accomplishments and service to their communities. The resolution was adopted and referred to the Senate.

#### S. 584: Assisting Children

#### Senn

Senator Sandy Senn (R-Charleston) and Senator Katrina Shealy (R-Lexington) introduced a bill to require all school districts to develop policies to ensure sufficient staff are present when services of a personal nature are being provided to handicapped children. Assistance of duties include eating, toileting, or dressing.

The bill was referred to the Senate Education Committee.
