State Board of Education Regulation 43-170

Last fall, the State Board of Education (SBE) released a proposed change to the regulations regarding selection of instructional materials.

As a reminder, this proposed regulation establishes two main guidelines for instructional materials:

- Age and developmentally appropriate: materials must be "suitable to particular age groups...based on developing cognitive, and behavioral capacity typical for the age group." The proposal also states that a material is not age appropriate if it contains visual depictions or descriptions of "sexual conduct" as defined in state statute or if it is considered "indecent" or "obscene" under the broadcast guidelines for the Federal Communications Commission.
- Educationally suitable: the material must be aligned with the "instructional program of the school and district," which means it must be connected to the standards laid out in the Profile of a South Carolina Graduate.

As it currently stands, this regulation would ban classic works of literature such as Romeo and Juliet, The Odyssey, The Scarlet Letter, The Adventures of Huckleberry Finn, and others.

A public hearing will be held on this regulation at 1 p.m. on Feb. 13 at the Rutledge Conference Center in Columbia.

S.305: Work Experience for New Teachers

For individuals seeking an initial educator certificate, the Senate has proposed counting prior relevant work experience towards certification and to allow

educators to start on a higher salary step. If passed, <u>S.305</u> would allow individuals with at least five years of relevant experience, within ten years prior to seeking the certificate, to count those years towards a higher salary step.

The Senate scheduled this bill for special order on Tuesday, where they passed several clarifying amendments. One of these amendments specifies that the bill only considers years of relevant work experience for salary schedule advancement.

Another amendment clarifies that educators who entered the profession prior to July 1, 2023, may request to have relevant work experience considered for purposes of advancing on the salary schedule during the current year only.

This means that current educators would not receive retroactive pay for increased years of experience.

The bill was passed unanimously and will now go to the House.

S.905: Read to Succeed

On Tuesday, The Senate Education Committee had a hearing on <u>S.905</u>, which would eliminate Read to Succeed requirements for educators who are not directly involved in teaching early literacy. It also directs educators to use the "Science of Reading" approach to teach literacy and reading, requires that third graders who cannot demonstrate reading proficiency be held back, and extends summer reading camps so they start earlier than third grade.

This bill is very similar to S.418, which was introduced last year but did not make it through the legislative process.

H.3309: Seizure Safe Schools Act

The House began debate on <u>H.3309</u>, the "Seizure Safe Schools Act" on Thursday, but did not take a vote. This bill would require public schools to create seizure response plans that include training for educators so that they know how to recognize signs and symptoms of seizures, an Emergency Action Plan (EAP) for situations when a student has a seizure, and allow parents to give permission for students with epilepsy to self-administer medication as necessary. Governor's State of the State Address

On Wednesday, Governor Henry McMaster gave his State of the State Address to the General Assembly. In the speech, he discussed South Carolina's economic growth and touted the businesses that are investing in the state, the record growth of our tourism economy, and a surplus in the state budget.

Gov. McMaster outlined his budget priorities, including increased funding for environmental conservation, increased funding for 4k, funding vouchers, and raising the starting salary for educators to \$50,000 by 2026.

Governor McMaster also attacked labor unions, claiming that they pose a "clear and present danger" to our state's economic success. The Governor claimed that his administration would "fight [labor unions], all the way to the gates of hell. And we will win."

Democratic Representative Roger Kirby delivered the response to the State of the State, where he criticized Gov. McMaster for failing to address South Carolina's low national rankings in healthcare and education and criticized the former Comptroller's mishandling of \$3.5 billion of state money.

HB3309: SEIZURE SAFE SCHOOLS ACT (Gilliam, L)

HB4649: PRIVATE SECURITY SERVICES IN PUBLIC SCHOOLS (Bannister, B) A BILL TO AMEND THE SOUTH CAROLINA CODE OF LAWS BY ADDING SECTION 59-19-275 SO AS TO PROVIDE PUBLIC SCHOOL DISTRICTS WITH MORE THAN FIFTEEN THOUSAND STUDENTS MAY USE CERTAIN SECURITY PERSONNEL TO PROMOTE SAFETY AND SECURITY ON SCHOOL PREMISES IF LICENSED AS A PROPRIETARY SECURITY BUSINESS, AND TO PROVIDE DISTRICTS REMAIN OBLIGATED TO USE SCHOOL RESOURCE OFFICERS AS OTHERWISE PROVIDED BY LAW; BY AMENDING SECTION 40-18-60, RELATING TO PROPRIETARY SECURITY BUSINESS LICENSURE. H. 4918: Urging Congress to Extend Summer EBT Program Deadline Ott

Representative Russell Ott (D-Calhoun) and others introduced a House resolution to urge Congress to extend the deadline for the Notice of Intent for the 2024 Summer Electronic Benefit and Transfer Program for Children.

H. 4944: Charter Schools

provisions concerning the sponsorship, oversight, governance, and operation of charter schools.

H. 4946: Urging Congress to Extend or Waive Summer EBT Program Deadline

Representative Marvin Pendarvis (D-Charleston) introduced a House resolution to urge Congress to either extend the deadline for the Notice of Intent for the 2024 Summer EBT Program or waive the deadline to permit states to submit a Notice of Intent after January 1, 2024.

H. 4952: Lexington County School Districts, Partisan Elections

Elections and Voter Registration Information

There are two Presidential Primaries happening in February:

- The first is the Democratic Presidential Primary that is **next Saturday**, **February 3**. The voter registration deadline for that election was on Thursday, January 4.
- The second is the Republican Presidential Primary on Saturday, February 24. The voter registration deadline for that election was on Thursday, January 25.

Additionally, 17-year-olds who will be 18 by the time of the election are allowed to pre-register to vote. In order to vote in an election, you must be registered to vote at least 30 days prior to the election.
