State Board of Education Regulation 43-170

The State Board of Education (SBE) held a hearing on Tuesday to discuss a proposed regulation that would change the existing process for selecting instructional materials.

As a reminder, this proposed regulation establishes two main guidelines for instructional materials that use narrow definitions of "age appropriate" and "educationally suitable," which would ban several classic works of literature, such as The Odyssey, Romeo and Juliet, The Scarlet Letter, and others.

To make this regulation less damaging, members of the <u>Freedom to Read</u> <u>Coalition</u> worked with librarians to develop a list of amendments to Regulation 43-170. Those amendments (listed in full in <u>last week's Members Matter</u>) were presented to the SBE ahead of Tuesday's meeting.

The SBE decided to adopt the following amendments:

- Removed the requirement that materials meet FCC guidelines;
- Added a requirement that challenges must be from parents or legal guardians – this changes prior language that allowed any taxpayer to file a complaint against a book;
- Placed limits on the number of challenges to five per person each calendar month;
- · Allows districts can choose to refer challenges to the State Board;
- Removes the requirement that districts review all existing materials.

The regulation will now go to the legislature, which has the option to either approve the regulation, not approve the legislation, or send it back to the SBE with requested changes. If the legislature takes no action within 120 days, the regulation is automatically approved as-is.

The SCEA had planned to testify in opposition, but the SBE limited public comment so we were not able to. You can read our planned testimony at the link below.

Thank you to everyone who wrote a letter, contacted their State Board member, and came out to speak at the meeting on Tuesday. Because of your advocacy efforts, this regulation is now much less damaging than the original proposal.

S.905 and S.418: Read to Succeed

The Senate Education Committee held another hearing on <u>S.905</u>, which would eliminate Read to Succeed requirements for educators who are not directly involved in teaching early literacy. It also directs educators to use the "Science of Reading" approach to teach literacy and reading, requires that third graders who cannot demonstrate reading proficiency be held back, and extends summer reading camps so they start earlier than third grade.

The committee approved the bill, which now goes to the Senate floor.

This bill is very similar in language to $\underline{S.418}$, which was introduced last year but stalled in the Senate after the House made drastic changes. The Senate Education Committee took the language from S.905 and placed it back into S.418 using what's called a "strike-and-insert" amendment, which are frequently used to change large portions of a bill.

Putting that language into both bills allows them to have options for passing this legislation. We will continue to monitor both bills as they move through the legislature.

H.4374: Social Studies Curriculum

<u>H.4374</u> is a bill that would change the way that social studies curriculum is evaluated. This bill was originally introduced in April of last year and directed social studies curricula to take a "traditional approach to history, which emphasizes the importance of leading individuals and key events in shaping the political, constitutional, intellectual, economic, diplomatic, and military history of the United States."

The bill now includes a provision that requires that anyone responsible for reviewing or revising state standards "may not have a record of promoting political or social issues in classroom instruction, including the presentation of theoretical perspectives that are critical of society and culture as being factual" and "may not have a record of supporting narratives which characterize the founding of the United States, its evolution to a constitutional republic, or the history of the United States in general, as a story of oppression." This bill also gives State Superintendent Ellen Weaver the authority ("at her discretion") to remove someone if she feels they have violated these provisions.

The House Education & Public Works Committee held a hearing on this bill on Tuesday, but no action was taken.

H.4624: Gender-Affirming Care

On Wednesday and Thursday, the Senate Medical Affairs Subcommittee held hearings on <u>H.4624</u>.

Most of this bill pertains to medical care and seeks to ban minors from receiving "gender-affirming care." It also bans Medicaid from reimbursing for gender-affirming care provided to individuals under the age of 26.

There is one section that prevents public school employees from "withholding from a minor's parent or legal guardian information related to the minor's perception that [their] gender is inconsistent with [their] sex." While the most problematic language regarding educators has been removed, this bill still puts LGBTQ students at risk and prevents them from accessing necessary genderaffirming care.

The SCEA is concerned that H. 4624 would prevent a safe environment for educators to effectively communicate with students. As they did during the House hearings, several doctors, transgender individuals, educators, and parents of transgender children spoke to the Senate Subcommittee about the harm this bill would cause.

Our Center for Educator Wellness and Learning (CEWL) hosted a <u>livestream</u> <u>discussion</u> about this bill, gender affirming care, and the negative impacts this will have on LGBTQ+ people in South Carolina.

The committee did not take any action on the bill and will continue discussion on it at future committee meetings.

H.4866: Smart Heart

<u>H.4866</u> would require public schools to develop and implement a cardiac emergency response plan, an athletic emergency action plan, and to ensure that every school has at least one Automatic External Defibrillator (AED) and that the AED is easily accessible during athletic events.

The bill was introduced last month and is currently in the House Education and Public Works Committee.

H.4709: Cursive Writing Coursework

<u>H.4709</u> would require cursive writing to be taught in public schools starting in second grade and continuing through fifth grade. Cursive handwriting has not been a curriculum requirement in South Carolina since 2008.

The House Education and Public Works K-12 Subcommittee held a hearing on the bill on Tuesday and gave it a favorable report. It now heads to the full House EPW committee.

State-level Candidate Filing Deadline

Filing for state-level candidates begins on March 1 and closes on March 30, 2024. As a reminder, the full House and the Senate are up for reelection this year.

The SCEA will monitor candidate filing and provide more information about candidates and upcoming elections as they get closer.

Paid Student Practicums

H.4655: Physical Education and Activity

<u>H.4655</u> would change the existing requirements for PE and physical activity for students in kindergarten through eighth grade.

This bill would increase the minimum required time for physical education (PE) to ninety minutes per week for elementary school students and sixty hours per year for middle school students.

Additionally, this bill would require schools to provide a minimum of 20 minutes of daily unstructured recess to students in kindergarten through eighth grade and provide a plan for indoor recess periods during inclement weather.

The House Education & Public Works Committee held a hearing on this bill on Tuesday. They reviewed a few proposed amendments that seek to ensure unstructured PE does not negatively impact classroom time and agreed to hold another hearing to discuss those and report on the bill.

SC TEACHER Retention Report

SC TEACHER is an organization that gathers data on education in South Carolina, including an annual working conditions report. They recently released a report on South Carolina teacher retention. The report analyzes data from eighty school districts over the past six years to address how retention rates differ from district to district and how those rates are impacted by school factors.

House Recess and Budget Updates

To give the Ways and Means Committee time to catch up on the budget, the House will be furloughed next week. They will resume normal session on Tuesday, February 27th.

The Ways & Means Committee has not yet created a formal state budget. The Governor and the Department of Education released their budgets at the beginning of the year; however, these are not binding. In effect, the Governor's budget is a "wish list" that signifies his legislative priorities.

HB4538: SOUTH CAROLINA STUDENT PHYSICAL PRIVACY ACT (Cromer, A) A BILL TO AMEND THE SOUTH CAROLINA CODE OF LAWS BY ENACTING THE "SOUTH CAROLINA STUDENT PHYSICAL PRIVACY ACT" BY ADDING ARTICLE 4 TO CHAPTER 23, TITLE 59 SO AS TO STATE PURPOSES, PROVIDE DEFINITIONS, PROVIDE THAT EVERY PUBLIC SCHOOL RESTROOM AND CHANGING FACILITY THAT IS ACCESSIBLE BY MULTIPLE PERSONS MUST BE DESIGNATED FOR USE ONLY BY MEMBERS OF ONE SEX, AND TO PROVIDE CIVIL PENALTIES.

HB4655: UNSTRUCTURED AND SELF-DIRECTED RECESS IN PUBLIC SCHOOLS

SB245: BOOSTER CLUBS

(Kimbrell, J) A BILL TO AMEND THE SOUTH CAROLINA CODE OF LAWS BY ADDING SECTION 59-17-170 SO AS TO PROVIDE THAT A PERSON WITH CERTAIN CRIMINAL CONVICTIONS IS PROHIBITED FROM SERVING AS THE TREASURER OF A BOOSTER CLUB, TO PROVIDE THAT EACH BOOSTER CLUB WITHIN A SCHOOL DISTRICT SHALL ANNUALLY REGISTER WITH THE SCHOOL BOARD, TO PROVIDE THAT THE SCHOOL BOARD MUST RUN A CRIMINAL BACKGROUND CHECK TO DETERMINE IF THE TREASURER OF A BOOSTER CLUB IS PROHIBITED FROM SERVING IN THAT ROLE DUE TO A CRIMINAL CONVICTION, AND TO DEFINE NECESSARY TERMS.

The Republican Presidential Primary will be held on Saturday, February 24, 2024.

While it is too late to register to vote in the upcoming Republican Presidential Primary, 17-year-olds who will be 18 by the time of the election are allowed to pre-register to vote. In order to vote in an election, you must be registered to vote

at least 30 days prior to the election.
