# Dr. Jill Biden Rally and Becky Pringle Visit

Last Friday, we had the privilege of hosting fellow educator and First Lady Dr. Jill Biden for a Get Out the Vote Rally in Columbia. Dr. Biden thanked educators in South Carolina for helping elect her husband and spoke about the things that President Biden has done to help educators, such as safely reopening schools, expanding student loan forgiveness through the Public Service Loan Forgiveness program, and passing the bipartisan gun safety law.

Prior to the rally, NEA President Becky Pringle and The SCEA President Sherry East met with members of The Student SCEA to discuss the future of education and current challenges facing aspiring educators, including program closures, how to handle anti-public-education elected officials, and ways to increase mentorship between students and current educators.

# H.3309: Safe Seizure Schools Act

The House began debate on <u>H.3309</u>, the "Seizure Safe Schools Act" last week but did not take a vote until this week. This bill would require public schools to create seizure response plans that include training for educators so that they know how to recognize signs and symptoms of seizures, an Emergency Action Plan (EAP) for situations when a student has a seizure, and allow parents to give permission for students with epilepsy to self-administer medication as necessary.

H.3309 was passed on Wednesday in a 114-0 vote. It will now go to the Senate.

## S.905: Read to Succeed

The Senate Education Subcommittee held another hearing on <u>S.905</u>, which would eliminate Read to Succeed requirements for educators who are not directly involved in teaching early literacy. It also directs educators to use the "Science of Reading" approach to teach literacy and reading, requires that third graders who cannot demonstrate reading proficiency be held back, and extends summer reading camps so they start earlier than third grade.

The subcommittee voted to send the bill to the full committee by giving it a favorable report. The full committee will discuss this bill at their next meeting.

### H.5022: Universal Free Meals at Public Schools

<u>H.5022</u>, filed this past Thursday, would allow schools that participate in the school breakfast program to provide breakfast and lunch to all students without charge. This is a companion bill to S.148, which was filed last year but did not leave committee.

<u>Research has shown</u> that providing universal school meals improves academic performance, in addition to significantly curbing child hunger. NEA has <u>long</u> <u>advocated</u> for universal school meal programs.

H.5022 is currently in the House Ways and Means Committee. They have not scheduled a hearing on the bill, so we are asking members to contact the Committee and ask them to support this bill. You can send your email at the link below.

## H.3728: Transparency and Integrity in Education Act

<u>H.3728</u> is a censorship bill that was passed at the end of last year. Supporters claim this bill's intention is to encourage transparent and fact-based school lessons on complex topics; however, this bill is part of a national agenda to inject political censorship into classrooms.

Other states with similar legislation have illustrated how the impact of this measure goes far beyond the stated intent and we anticipate that could happen in South Carolina as well.

This bill was passed by both the South Carolina House and the Senate; but each chamber passed a slightly different version of the bill. It is currently awaiting a hearing in a conference committee. The House version of this bill would allow any parent or guardian, from anywhere in the country, to file a lawsuit against a district or educator without ever having a conversation with the accused educator or their administration.

The SCEA is concerned that this bill—especially if the provision described above is included—will further drive educators out of the classroom and chill important discussions of race, gender, and other important issues.

The conference committee has not yet taken action on 3728, so we are asking members to share stories of how they have been impacted by censorship policies. If you have not been impacted yet but fear that you will be, please share those concerns as well. We plan to share these stories with elected officials to try and stop this harmful legislation.

## H.4700: Social Media Regulation Act

<u>H.4700</u> is a bill that would prohibit certain minors from being social media account holders and would provide parents/guardians certain information surrounding a minor's account. The House brought this bill to the floor on Wednesday, where it passed with a 105-1 vote.

During the floor discussion, the House amended the bill to direct the Department of Education to develop a model program to educate students in grades 6-12 about online safety while using social media. The amendment directs the program to contain information on the following topics:

- social, emotional, and physical effects of social media;
- the negative effects on mental health;
- the distribution of disinformation and misinformation on social media;
- how social media influences and manipulates thoughts & behaviors;
- how to maintain personal security, identify cyberbullying, and how to report such behaviors to authorities.

### H.4655: Physical Education and Activity

<u>H.4655</u> would change the existing requirements for PE and physical activity for students in kindergarten through eighth grade. This bill would increase the minimum required time for physical education (PE) to ninety minutes per week for elementary school students and sixty hours per year for middle school students.

Additionally, this bill would require schools to provide a minimum of 20 minutes of daily unstructured recess to students in kindergarten through eighth grade and provide a plan for indoor recess periods during inclement weather.

# State Board of Education Regulation 43-170

Last fall, the State Board of Education (SBE) released a proposed change to the regulations regarding selection of instructional materials.

As a reminder, this proposed regulation establishes two main guidelines for instructional materials:

- Age and developmentally appropriate: materials must be "suitable to particular age groups...based on developing cognitive, and behavioral capacity typical for the age group." The proposal also states that a material is not age appropriate if it contains visual depictions or descriptions of "sexual conduct" as defined in state statute or if it is considered "indecent" or "obscene" under the broadcast guidelines for the Federal Communications Commission.

- Educationally suitable: the material must be aligned with the "instructional program of the school and district," which means it must be connected to the standards laid out in the Profile of a South Carolina Graduate.

As it currently stands, this regulation would ban classic works of literature such as Romeo and Juliet, The Odyssey, The Scarlet Letter, The Adventures of Huckleberry Finn, and others.

# A public hearing will be held on this regulation at 1 p.m. on Feb. 13 at the Rutledge Conference Center in Columbia.

#### HB3309: SEIZURE SAFE SCHOOLS ACT (Gilliam, L)

A BILL TO AMEND THE SOUTH CAROLINA CODE OF LAWS BY ENACTING THE "SEIZURE SAFE SCHOOLS ACT" BY ADDING SECTION 59-63-97 SO AS TO REQUIRE THE ESTABLISHMENT OF SEIZURE ACTION PLANS IN PUBLIC SCHOOLS, AND TO PROVIDE REQUIREMENTS FOR SUCH PLANS AND THEIR IMPLEMENTATION, AMONG OTHER THINGS.

#### HB3430: SCHOOL BOARD MEMBERS (Collins, N)

A BILL TO AMEND THE SOUTH CAROLINA CODE OF LAWS BY AMENDING SECTION 1-11-720, RELATING TO ENTITIES WHOSE EMPLOYEES AND RETIREES ARE ELIGIBLE FOR STATE HEALTH AND DENTAL INSURANCE PLANS, SO AS TO INCLUDE SCHOOL BOARD MEMBERS.

#### SB245: BOOSTER CLUBS (Kimbrell, J)

A BILL TO AMEND THE SOUTH CAROLINA CODE OF LAWS BY ADDING SECTION 59-17-170 SO AS TO PROVIDE THAT A PERSON WITH CERTAIN CRIMINAL CONVICTIONS IS PROHIBITED FROM SERVING AS THE TREASURER OF A BOOSTER CLUB, TO PROVIDE THAT EACH BOOSTER CLUB WITHIN A SCHOOL DISTRICT SHALL ANNUALLY REGISTER WITH THE SCHOOL BOARD, TO PROVIDE THAT THE SCHOOL BOARD MUST RUN A CRIMINAL BACKGROUND CHECK TO DETERMINE IF THE TREASURER OF A BOOSTER CLUB IS PROHIBITED FROM SERVING IN THAT ROLE DUE TO A CRIMINAL CONVICTION, AND TO DEFINE NECESSARY TERMS.

## Introductions of Interest

H. 4971: SCRS and PORS Earnings Limitation Williams

Representative Robert Williams (D-Darlington) and others introduced legislation to remove the \$10,000 earnings limitation on employees who return to covered employment under the South Carolina Retirement System and the Police Officers Retirement System for those who retired before January 2, 2025. This bill was referred to the House Ways and Means Committee.

#### H. 4982: Free School Meals

#### Moore

Representatives JA Moore (D-Charleston), Annie McDaniel (D-Fairfield), Pat Henegan (D-Marlboro), Robert Williams (D-Darlington), Roger Kirby (D-Florence), Lonnie Hosey (D-Barnwell), and Bill Clyburn (D-Aiken) introduced legislation to provide that eligible schools will provide breakfast and lunch without charge to all students. Eligible schools that offer school breakfast and school lunch to all students without charge would receive additional funding in the general appropriations act to support their school meals operations.

The bill would require all schools to provide at least 30 minute lunch periods to all students between the hours of 11:00 a.m. and 2:00 p.m.

This bill was referred to the House Ways and Means Committee.

#### H. 4986: SC Service Corps Act

#### Moore

Representatives JA Moore (D-Charleston) and Annie McDaniel (D-Fairfield) introduced legislation that establishs the South Carolina Service Corps as a division of the Department of Employment and Workforce. Service opportunities of the Corps include:

1) green jobs in service of activities or industries that contribute substantially to preserving or restoring environmental quality;

(2) health services, by applicants with the necessary qualifications, to provide medical, dental, psychological, or other related services as considered appropriate by the South Carolina Service Corps administration;

(3) services that benefit the developmental and educational needs of early childhood; and

(4) services that provide exposure to, and participation in, the arts or humanities. This bill was referred to the House Labor, Commerce and Industry Committee.

# H. 4994: Water Testing in Childcare Facilities and Schools

Moore

Representatives JA Moore (D-Charleston), Pat Henegan (D-Marlboro), Annie McDaniel (D-Fairfield) and Lonnie Hosey (D-Barnwell) introduced legislation to require every childcare learning center and school to test their drinking water outlets for lead contamination and remediate any lead contamination identified no later than June 30, 2025.

This bill was referred to the House Education and Public Works Committee.

#### H. 4997: School Bond Elections

#### Newton

Representative Brandon Newton (R-Lancaster) introduced legislation to require school bond elections be held on the first Tuesday after the first Monday in November.

This bill was referred to the House Judiciary Committee.

H. 5014: Lexington County School District Property Tax Relief Act Extension Caskey

Representatives Micah Caskey (R-Lexington), Nathan Ballentine (R-Richland),

Paula Calhoon (R-Lexington), Cal Forrest (R-Saluda), Jay Kilmartin (R-Lexington), RJ May (R-Lexington), Donald Ryan McCabe (R-Lexington), Russell Ott (D-Calhoun), Bill Taylor (R-Aiken), Joe White (R-Newberry), and Chris Wooten (R-Lexington) introduced legislation to extend the 1% sales tax imposed by the Lexington County School District Property Tax Relief Act for an additional seven years.

This bill was referred to the Lexington Delegation.

#### H.5022: Free School Meals

#### Erickson

Representative Shannon Erickson (R-Beaufort) and others introduced legislation to provide that eligible schools will provide breakfast and lunch without charge to all students. Eligible schools that offer school breakfast and school lunch to all students without charge would receive additional funding in the general appropriations act to support their school meals operations.

The bill would require all schools to provide at least 30 minute lunch periods to all students between the hours of 11:00 a.m. and 2:00 p.m.

This bill was referred to the House Ways and Means Committee.
